## ANTIRAGGING COMMITTEE GDC, KOZHIKODE 2020-21

Ragging is a heinous crime and a criminal offence as declared by the Supreme Court of India. Govt. Dental College, Kozhikode has been successful in creating a ragging – free campus. We have a 'Zero tolerance" policy towards ragging, i.e.no act of ragging, major or minor, shall go unnoticed and no ragger, male or female, student or non-student, shall go unpunished.

Our college believes in fostering a harmonious relationship amongst its students and strictly condemns ragging. We have an anti – ragging cell which comprises of the Principal and other staff members. The students are sensitized on the ill effects of ragging and the legal proceedings in curbing the practice. Awareness is created via orientation programmes in the first year as well as before the commencement of each academic year. The hostel too is under strict vigilance and we ensure that students learn to respect and accept the new students into their fold. Objective:

In view of directions of Hon"ble Supreme Court in SLP No 24295 of 2006 dated, 16/05/2007 and civil appeal no 887 of 2009 dated 8/05/2009 to prevent, prohibit and eliminate the scourge of ragging. Ragging is a criminal offence as per the Supreme Court Verdict. It adversely impacts the standards of higher education. So, it is mandatory to implement anti-ragging measures and monitoring measures in every college.

### What constitutes Ragging?

- Any conduct by any student or students whether by words spoken or written or by any act which has the effect of teasing, treating or handling with rudeness to a fresher or any other student.
- Asking any student to do any act which such student will not in the ordinary course do or generating a sense of shame to fresher or any other student.

- Any act by a senior student that prevents or disturbs the regular academic activity of any other student or fresher.
- Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- Any act of financial extortion or forceful expenditure burden put on a fresher by other students.
- Any act of physical abuse, including sexual abuse, homosexual assaults, stripping, forcing obscene causing bodily harm or any other damage to health or person.
- Any act or abuse by spoken words, emails, posts and public insult to a fresher.
- Any act that affects the mental health and self-confidence of a fresher or any other student.

Actions to be taken against students for indulging ragging.

- 1. On getting information about ragging, Principal may convene a meeting of HODs and if the information is correct, immediately convene meeting of anti-ragging committee.
- 2. The anti-ragging committee of the college shall take an appropriate decision, with regard to punishment or otherwise, depending on the facts of each incident of ragging on its nature and gravity.
- 3. Every single incident of ragging a first information report (F I R) must be filed by the institutional authorities with local police authorities
- Depending upon the nature and gravity, the possible punishments at the college level can be
  - i. Suspension/ expulsion from the hostel
  - ii. Suspension from attending classes
  - iii. Cancellation of admission
  - iv. Debarring from appearing in any test/ examination
  - v. Expulsion from the college
